Dear Families:

N.J.S.A. 18A:38-1 and N.J.A.C. 6A:22, require that a free public education be provided to students between the ages of 5 and 20, and to certain students under 5 and over 20 as specified in other applicable law, who are:

- Domiciled in the district;
- Living with a person, other than the parent or guardian, who is domiciled in the district and is supporting the student without compensation;
- Living with a person, other than the parent or guardian, where the parent/guardian is a member of the military called to active service in time of war or national emergency;
- Living with a parent or guardian who is temporarily residing in the district; or
- Homeless.

The Upper Township School District has developed and implemented a strict Residency Verification Program to protect our community resources. The objective is to ensure that only those children eligible to attend school in our District are doing so and that any non-eligible students are appropriately removed from our attendance rolls. Please be advised that the District will pursue all available options against non-residents enrolling their child/children in the District; as well as against any individual furnishing false information for the purpose of enrolling non-resident students.

The Residency Verification Program comprises, among other things, a thorough review of applications for enrollment, documentation verification, periodic investigations, requests for validation of those previously determined eligible for attendance, and requests for additional information. In accordance with N.J.A.C. 6A:22-4.1, please be aware that any initial determination of the student's eligibility to attend school in the District is subject to a more thorough review and subsequent re-evaluation, and that tuition may be assessed in the event that an initially admitted student is later found to be ineligible.

Enclosed please find a list of documents that the District requires for proof of residency. Proof of residency must be emailed to Nicole Schneider (schneider@upperschools.org) or shown at the Board Office, located at 525 Perry Road, Petersburg, New Jersey, no later than **August 23, 2021**.
